WHY? KEY ISSUES IDENTIFIED

- **Persistent and serious Impact Gap** between the policy formulation and the reality on the ground in the area of drug prevention and treatment
- **Lack of connection** between the priorities of the United Nations and the civil society organizations to realize the objectives of the world drug problem
- **Limited progress** in the area of drug prevention and treatment due to the lack of inclusiveness

WHO? UNODC

- ✓ **Collaboration with Civil Society:** UNODC works with some **500 CSOs** at the local, national, regional and global level to advance balanced approaches to drugs, which already led to greater access in drug treatment and care;
- ✓ **Expertise and experience:** UNODC increased access to evidence and rights-based treatment and care in more than **40 countries** around the world (e.g. Cambodia, Serbia, Brazil and Tanzania)

WHO? VNGOC

- ✓ **Effective participation of NGOs:** VNGOC ensure a comprehensive, structured, meaningful and balanced **participation of civil society**. Members are actively involved in and represent a diversity of views among the entire range of services and programs, including prevention, harm reduction, treatment and recovery at the policy and program level;
- ✓ **Bring CSOs voice in the international debate:** VNGOC enable NGOs to contribute to **UN Drug policy decision** making by collaborating with the Commission on Narcotic Drugs
